2. SUBJECT

3. START OF BUSINESS RELATIONSHIP

The contractual relationship starts on the day when the system owner receives a correctly completed application form confirmed by e-mail an by fax: +386 1 230 78 92.

4. START OF JOB AD POSTING

The system owner is liable for posting the relevant ad on the day agreed in the order. If the posting date is not specified the contractual parties can agree any date which the client has to e-mail to the system owner who has to confirm the requested date. The condition of a written confirmation is fulfilled when the system owner receives a confirmation of the order by e-mail. The client is fully responsible for a complete and suitable delivery of advertising materials. The materials should be delivered at least 3 working days prior to the job posting start date

5. RIGHT TO REFUSAL

We reserve the right to refuse to distribute an ad because of its content, source or technical format if the ad violates any statutory or public prohibitions or if it is morally disputable.

6. CLOSE OF CO-OPERATION

The co-operation takes place when:
